
## Thriplow Parish Neighbourhood Plan

QUESTIONNAIRE RESULTS



Neighbourhood planning is a way for communities to take a proactive approach to deciding the future of the places where they live and work.

Communities can use a Neighbourhood Plan to help shape the future development and use of land in their neighbourhood. This includes the development of homes, shops, offices and infrastructure.

A Neighbourhood Plan helps set out a community's vision for their area over the next ten to twenty years. Unlike a Parish Plan, once adopted the Neighbourhood Plan has the same legal status as the wider Local Plan. The Neighbourhood Plan will be part of the statutory development plan for the district. It will be used in deciding planning applications for the area.

In South Cambridgeshire it is the parish councils who are the 'qualifying bodies' that can initiate the process and work with the local community to develop their Neighbourhood Plan. As the Local

Planning Authority, South Cambridgeshire District Council has a duty to support the parish council and local community through the neighbourhood planning process.

### What can a Neighbourhood Plan do?

The Neighbourhood Plan can:

- propose more development than is suggested in the Local Plan
- identify the most suitable sites for development, should it be required
- help to determine what type and design of development should take place

The Neighbourhood Plan cannot:

- 1. propose less growth than in the Local Plan
- 2. prevent any development from ever taking place in an area
- 3. be prepared without community input and support
- 4. be in conflict with national or local planning policies











## Where you live


### 1. Where do you live in the Parish?

Number of individuals taking part in the survey





### 2. How long have you lived here?



### **HEATHFIELD: TRANSPORT & CONNECTIVITY**

Cycle access from Heathfield, not on busy A505.

Public transport, access to a shop for us in Heathfield and an area for community get together could be better.

Access via bus, shop in Heathfield

Parking at Ringstone - I think the parking in front of the Green should be end on to allow more parking. The fact is that it already happens because it is needed but this risks damaging the grass. A better Community spirit between Heathfields and Thriplow. I am always so saddened that relations between Thriplow as a village and Heathfields don't seem as positive as they could be. My experience is that everyone within the parish wants the same thing - to protect what wonderful assets we have and improve things where needed. I would like to see everyone working together more and I hope this Neighbourhood plan will be the catalyst for that. Amenities - amenities at Heathfields are poor. Personally, I feel we need a shop, even if it's just for essentials. I would love to see the village shop in Thriplow create a sub-shop at Heathfields so the 400 residents at Heathfields could contribute more freely to supporting it. The more people buying from the shop, the better for the Community as a whole. The shop does a fantastic job - I am alwasy suprised by the quality and variety of things available within the shop and would love to see Heathfields also benefit from this without having to get in their car. Iceni - personally, I would like to see this redeveloped for housing. I think it would improve the aesthetics at Heathfields and put the land to good use. However, I think it is absolutely essential that any developed should include the provision of a space for a Community shop or improved amenities.

Transport links, road safety, better leadership.

Better links between Heathfield and village, better representation for the Heathfield Ward on TPC, the junction on A505 and gravel pit lane.

Treating us the same as Thriplow, we feel stigmatised by where we live and feel like poor relatives, but more of us live here. It leaves a very bitter taste that the PC prioritises the village with virtually no funds coming our way. A local shop and some kind of hub / community centre for us to use here. I get that there is a hall in Thriplow but we should have our own, we could have kids clubs etc.

A shop in walking distance from Heathfield A Social hub in Heathfield. Things for older children to do in Heathfield. Kid club / Teams in Heathfield. Safe exit of the Heathfield ward.

Amenities, better access to public transport.

I would like to see more Community areas around Heathfield, such as benches for friends and families to gather around the green spaces. A community hall would serve as a very useful space within Heathfield.





### **HEATHFIELD: FACILITIES & AMENITIES**

Broadband - when we first moved in we wanted to change from Sky, but were told that BT (the only other broadband company we could use) had a waiting list of over 2 years for the area. Also our bins are not collected on average once every other month and whilst this is not a massive problem, it's very annoying having to fill the form out and phone up each time.

Broadband drops out a lot.

Broadband goes off after heavy rain.

In the past we have had issued with broadband and mobile telephone network but over the last 10 years we have worked out which providers work best.

Mobile and telephone (including broadband) are limited to just one or two companies. Broadband is slow and signal is often slow or breaks.

Mobile networks are limited. Broadband is relatively slow and often cuts out when watching online.

Connectivity options dependent on single provider (BT). Mobile phone coverage patchy at times.

Poor broadband speed, telephone reception, the odd missed bin collection.

Poor signal with certain mobile providers.

Really slow broadband.

Reception on Vodafone is terrible.

Slow broadband & poor mobile coverage.

Slow speeds in area.

Sometime poor mobile signal. Council miss collecting bins sometimes.

We have big tankers driving past our houses alot to empty the sewage works, another route should be made availible on wider roads.

Electricity outages have occured roughly twice a year since I moved here, not always for very long, but any loss of electricity is a problem. Broadband is better today but rose from a very low level five years ago. High speed is still unavailable, yet we are 10 mins drive from Cambridge, supposedly a high tech hub.

We have power cuts - don't know why.

It seems that some days they can't be bothered to lift the bins.

Never take big boxes.

Not a problem with the rubbish collection itself, but sometimes the lorry can't get through due to parking situation at Ringstone, so bins aren't emptied.

One collection very two weeks not enough

Recycling/rubbish not taken when frozen shut (a tiny pull would loosen), recyling/rubbish spilled over on bin days and blown onto our drive. Mobile phone reception is terrible. Our broadband keeps dropping and we're told there's too many people for the line. Anglican water recently came out and sorted a problem with the sewers. (A large number of houses sewers empty into an area under our property. Not sure that has anything to do with the council though.

Rubbish wasn't collected, broadband connection is poor.

Since removing the black paper bin, it's stated that they would take extra recycling that is put in a box and they have not collected a box twice that I could not fit in my bin.

They don't take boxes if they're not in the bin.

My green bin is never collected, even though it is next to the blue and black ones and they are. I have to call every time for it to be emptied - no reason ever given for oversight.

Bins sometimes don't get emptied and often get put back in the wrong place or block cars in on the drive.





### **HEATHFIELD: TRANSPORT & CONNECTIVITY**

To clarify, the issue is the transport in the area - the roads cannot cope with more homes or businesses in this area without significant investment.

I think Heathfield should have some more houses, but the single access entrance and lack of any amenities will make it tricky and undesirable for those already living here let alone newcomers if nothing is changed to accommodate.

The roads cannot cope with traffic in and out now. Extra housing would be untenable with the access unchanged.

Without another access road at Heathfield I can't see how it can sustain any more houses. There is only room for 5 cars to leave per lights cycle. I rarely need to come in or out of Heathfield during peak hours but new houses would likely mean more people needing to go to and from work at peak times. Quality of life would suffer.

The junction between Gravel Pit Hill and A505 needs to be improved for safety.




# 26. Do you support the use of the following energy sources on either a domestic or a larger scale basis in the Parish?

We need a water supply.


We took on an allotment that hadn't been taken for 7 years so i'm not sure we need any more.

Would be nice to see them fully used.




### 28. Please indicate the age group you fall in to




### 29. Please would you indicate your gender
